# 2019 Local Lodge 774 Officer Nominations and Elections

The policy and procedures of the Local Lodge Officer Nominations and Election (In accordance with the IAM Constitution and Local Lodge 774 Bylaws)

- Notification will be sent to all members by mail no later than 60 days prior to an election, at the last known address, of the time, date and location of the nominations and election. The District Secretary-Treasurer shall provide a suitable ballot for use at the **October** election. Polls will be open from 6:00 a.m. to 8:00 p.m. on voting day. (L.L. 774 Bylaws, Article III, Section 1)
- Any member in good standing may be nominated in a Local Lodge who is not barred from holding union office by applicable civil law or ineligible therefore as provided in this section.
  (IAM Constitution, Article B, Section 3)
- Nominations will be conducted at the regular meeting held in the month of September.
- No members shall be nominated for any office or as a Delegate or Alternate who is not present during the meeting at the time nominations are made, except when a written excuse is offered

- and accepted by the membership in attendance during the meeting when nominations are made. (L.L. 774 Bylaws, Article III, Section 4)
- All members nominated for Local Lodge officer, plant chairpersons, delegate and permanent committees must have attended fifty percent (50%) or more of the regular meetings held during the 12-month period ending the date of close of nominations per the IAM Constitution and any official IAM circulars, IAM directives and IAM guidelines for conducting Local Lodge elections. (L.L. 774 Bylaws, Article III, Section 13)
- Local Lodge Officer's have a three (3) year term, beginning in January following the election. (L.L. 774 Bylaws, Article III, Section 3)

## Kansas State Council Report -Gary Hall

Greetings Brothers and Sisters, "Turnaround has happened."
Turnaround means that if bills have not been passed by one chamber, they are dead and will not be considered by the other chamber. The exceptions to this rule are bills that are referred to the Appropriations, Tax, Judiciary and Federal and State Affairs committees.

Fair Share is one bill (HB2175) that is getting no hearing because of the discretion of the majority leadership and chairman. Fair Share has invoked more discussion about the work of unions such as the repeal of Right-to-Work in our state, and this is

good. Missouri's success of repealing Right-to-Work has spurred one Kansas legislator to introduce HCR5008, which if passed by 2/3 of each chamber, brings about a vote for a constitutional change to repeal Right-to-Work in Kansas. No hearings have been scheduled though.

With a stranglehold on bills that would benefit labor, committee chairs are letting zero bills by that even remotely could help Kansas' workers. Your voice matters, and it will be heard if you contact your legislators. We know if that doesn't work, your voice will be heard come election time! That is why it is so IM-PORTANT that we REGISTER and VOTE! People don't like to talk politics, I get it, but the truth

is our lives and our families lives are governed by what goes on in Topeka and Washington D.C. Our contracts are automatically changed to comply with the law if it changes. Our rights and benefits can be taken away by what happens in Topeka and Washington D.C. We must keep ourselves informed and contact our legislators when the need arises. We must be united and speak as a solid union voice! Please stay informed.

Know who your representatives are at a local, state and federal level. I speak for all of your Kansas State Council delegates when I say thank you for supporting our trip to Topeka!
