- Only members in good standing are entitled to vote. Election is by Plurality Vote. In cases of a tie, ties will be settled by a flip of a coin.
- **RETURN:** The Absentee Election Ballot must be USPS delivered by close of business the day prior to the Local Lodge Election, in order to be counted.


